### 3. Minutes of previous meeting:

- 3.1 Minutes of the 2021 Annual General Meeting
- **Motion**: that the minutes from the 2021 Annual General Meeting held on 17<sup>th</sup> July 2021 are true & correct. Moved: Andrew Allan (Oakleigh LAC); seconded: Julie Bicknell (Ballarat LAC). 78 delegates (of 86) voted in favour; 8 delegates abstained. Carried.

## 5. Presentation of audited 21/22 financial statements

- Russell Dmytrenko spoke briefly to the 21/22 audited financial statements. Key points:
  - Acknowledgement of the efforts and contribution of Manager, Finance Governance & Risk, Julie Green, Finance Director Danielle Wruck, the Finance Audit Risk Committee (Russell Dmytrenko, Shana Simonovski, Anthony McIntosh), and auditors Moore Stephens.
  - LAVic posted a surplus of \$83K for 21/22 year.
  - o The financial position has improved with net assets are up \$110K.
  - o Moore Stephens have undertaken a thorough audit & issued an unmodified audit opinion.
  - o LAVic has sufficient funds to ensure ongoing viability.

#### Questions:

- Steve Woolfe (Berwick LAC) what is the cost we pay for Timing Solutions?
  - Response from Anthony McIntosh (CEO: the cost per athlete for Timing Solutions is \$4.50 per registered member.
- Steve Woolfe (Berwick LAC) in the past two seasons, LAVic has posted healthy profits. What is the Board planning to do to put some of that money back into Centres & athletes to make volunteer's roles easier? Some of this money should be on current day members. From a Centre perspective, it's 'take, take take.' It's been about 5 years or so since athletes received a 'welcome pack', such as other sports provide. What's the Board's plan going forward?
  - Response from Russell Dmytrenko, Director: while the past two years have posted a profit, it hasn't always been the case. The Board challenged the LAVic team to break even in 21/22. The Board's new investment policy will provide strategic parameters for managing LAVic's assets moving forward.
  - Response from Steve Waugh (President): the strategic plan will be aligned to the Little Athletics Australia (LAA). LAVic will work with LAA and other States to develop assets, resources, and tools to build the capability of Centres. We don't want to hold onto the money and burden the members or blow it all over night. There's a process to work through. This is a decision for the new Board to make via its strategic plan.
- Cindy McDougall (Camperdown LAC) would LAVic supply welcome packs to athletes upon registration?
  - Response from Steve Waugh (President): while LAVic doesn't want to supply lots
    of plastic disposable rubbish to athletes, the Board will consider options for athlete
    welcome packs.

- Emily McLellan (Seaford LAC) posed a question regarding competition uniform suppliers and when/if the contracts are likely to change.
  - Response from Anthony McIntosh (CEO): the two apparel contracts are reviewed periodically and the suppliers will not change prior to the commencement of the new season. While the suppliers have experienced some supply difficulties in recent years due to the pandemic, the quality of the goods are high and their relationships with our sport are solid. It's in LAVic's interests that the contracts remain competitive.
- Andrew Allan (Oakleigh LAC) question regarding LAVic taking advantage of State funded Get Active Kids voucher incentive program.
  - o Response from Anthony McIntosh (CEO): explained how the Victorian system works, and that LAVic is working with SportsTG to ensure families can take advantage for the next round coming up soon. LAVic is working to make the vouchers as available as possible.

#### 7. Election of Directors

Anthony McIntosh spoke to the item. Key points:

- At the 2022 AGM, four Director roles become vacant.
- Eight nominations were received.
- A ballot was conducted in the weeks leading up to the AGM and Centres voted for their four preferred candidates.
- The following nominees have been elected to the LAVic Board: Steve Waugh, Malcolm Duncan, and Julie Bicknell.
- There was a tie for the fourth vacancy between Alana Macwhirter and Maryanne Gec.
- A secret ballot is required to be held during the AGM, in accordance with Regulation 13, 'Election of Directors' rule 1.5(f) with processes to accommodate the needs of delegates in the room and online. Each Centre in attendance is allowed to cast one ballot.

- Maryanne Gec received 38 votes; Alana Macwhirter received 16 votes; 4 Centres abstained.
- Maryanne Gec is declared duly elected to the Board.

#### 9. Other Business

#### Questions:

- Brett Perez (Mornington LAC) is there a plan to work with School Sport Victoria to get some consistency of rules?
  - o Response from Anthony McIntosh (CEO): LAA are looking nationally at alignment issues with School Sport Australia, so there's better alignment between all States, not just Victoria.
- Elishia Swain-Murphy (Stawell LAC): are there officials courses being held in regional Victoria?
  - Response from Anthony McIntosh (CEO): yes, there are plans for running training courses in country Victoria.
- Fiona Vanotti (Melton City LAC): logos on shorts. Athletes are struggling to comply.
  - Response from Anthony McIntosh (CEO): LAVic is committed to look at this issue.
- Scott Wilcock (Mentone LAC): will LAVic use funds to deliver OnTrack courses? Mentone is struggling to run it.
  - Response from Anthony McIntosh (CEO): LAVic is committed to look at boosting LAVic's capability to conduct OnTrack courses.
- Cindy McDougall (Camperdown LAC): would the Board consider providing branded LAVic tops to parents that have completed LAVic training course?
  - Response from Steve Waugh (President): we're aware of how beneficial these are. Good point.
- Anthea Mulholland (Wodonga LAC): will LAVic conduct Tiny Tots?
  - Response from Anthony McIntosh (CEO): LAVic is one of the only States not to conduct Tiny Tots. This will come into consideration in future years. This would require a Constitutional change.
- Mike Cahill (Sandringham LAC): lots of athletes seeking to join after Christmas. Will the Board consider discounting the LAVic fee after Christmas?
  - o Response from Anthony McIntosh (CEO): athletes already receive a discount at the end of the track & field season, which is at the half-way point of the full

- 11-month season. There is currently no consideration for offering a discount post-Christmas.
- Rachelle Evans (Seaford LAC): will LAVic be conducting U11s Skills Clinics this season?
   Will U8s be included in Region Carnival events? This helps secure volunteers.
  - Response from Anthony McIntosh (CEO): the Skills Clinic is under review at present. Other States involve U8s at Region events. Gippsland Country Region currently does this.
- Crystal Brown (Werribee LAC): will heats and finals be re-introduced to Region & State Championship events?
  - Response from Anthony McIntosh (CEO): this will be considered in balance with providing a quality experience, and the resources we have.
- Nicole George (Sandringham LAC): commented in favour of the re-inclusion of heats in Region & State Championship events.
