- Officials must hold a current WWC registration.
- Nominees must have officiated in an appointed role at three or more State and/or Region events during the relevant period.
- Nominations will be accepted from individuals, Clubs, Centres, Regions or LAVic.
- It is specifically for commitment to Little Athletics for the period from 1st May 2022 to 30th April 2023.
- Please use a separate nomination form for each nominee (no joint nominations).

 - o Region Relay Carnivals 2022
 - Region Track and Field Carnivals 2023
- Understanding of the rules relating to their position and ability to interpret them in a fair and unbiased manner.
- Demonstration of a positive attitude to the role(s) allocated to the official.
- Respect for fellow officials, athletes and parents.
- Communication and organisation. How well does the nominee communicate with others and are they well organised for their appointed position.
- Special Qualities. Any other qualities relevant to the nomination process.
