SECTION 1 - AUSTRALIAN LITTLE ATHLETICS CHAMPIONSHIPS

1.1 PURPOSE

(a) This policy sets down the guidelines and procedural requirements of the Association for participation in the Australian Little Athletics Championships.

1.2 **DEFINITIONS**

- (a) Some definitions used in this Policy are:
 - (i) LAVic Little Athletics Victoria
 - (ii) ALAC Australian Little Athletics Championships
 - (iii) CEO Chief Executive Officer of LAVic
- **(b)** References to Under 13, 14, and 15 competitors will be inclusive of both able-bodied and multi-class, except where otherwise noted.

1.3 LAVIC STATE MANAGEMENT TEAM

- (a) The LAVic State Team Management is comprised of at least five members, with representation from, at least, both male and female genders.
- (b) The size of the LAVic State Management Team will be determined noting best practice regarding supervision, alongside consideration of location, facilities, and structure of the competition.
- (c) The LAVic State Team Management may comprise several different roles, including Team Manager, Event Coach(es), and any additional roles, as required.
- (d) The Manager Education will select and appoint the LAVic State Management Team, in consultation with the CEO.
- (e) All members of the LAVic State Team Management shall have a current Working with Children's Check, have completed Play by the Rules' Child Safe standard modules, and read and signed the LAVic Code of Conduct for Dealing with Children and Young People.

1.4 LAVIC STATE SELECTION COMMITTEE

- (a) The role of the Selection Panel is to select the competitors for the Under 13 Team Competition, to selection, and/or finalise, the selection of the Under 14 and Under 15 competitors.
- **(b)** The LAVic State Team Selection Committee is comprised of at least five members.
- (c) The Selection Committee will convene on Monday the 11th of March to finalise the selection of competitors for the Australian Little Athletics Championships.
 - (i) Successful competitors will be contacted on Tuesday the 12th of March via email.

1.5 SELECTION CRITERIA AND PROCESS

1.5.1 Eligibility for Selection

- (a) To be eligible for selection a competitor must have:
 - (i) For the Under 13 Team competition, competed in the LAVic State Track & Field Championships in the current season.
 - (ii) For the Under 14 and 15 Individual competition, competed, in the current season, in the LAVic State Track & Field Championships or the Combined Events Championships (U15 Combined Event nominees only).
 - (iii) Remain in good standing with Little Athletics Victoria.

1.5.2 U13 Team Competition

- (a) The State Team Selection Committee will nominate sufficient competitors to facilitate options in each event, for both boys and girls.
- (b) The team will consist of up to 16 Boys and 16 Girls (Able-bodied), and 8 Multi Class competitors.
- (c) Competitors are selected, who in the view of the State Team Selection Committee, can obtain the maximum possible points score for the Team.
- (d) 16 disciplines can be contested by able-bodied competitors and 8 in multi-class.
- (e) Competitors are primarily chosen from their performances achieved at the LAVic State Track & Field Championships in their age group. To assist in finalising event selections, the State Selection Committee may consider performances at other events.
- **(f)** Multi-Class competitors must have a provisional or full classification.
- **(g)** Competitors will be required to attend the full duration of the ALAC event.

1.5.3 Under 14 Individual Competition

- (a) The State Team Selection Committee will select and/or finalise the selection of Under 14 competitors.
- **(b)** The team will consist of up to 28 boys and 28 girls (Able-bodied), and up to 16 Multi Class competitors.
- (c) In the first instance, the top two placed competitors at the current season LAVic State Track & Field Championships, in each contested discipline, will be considered for selection to ALAC.
 - (i) In the case of a draw that would result in more than LAVic's allotment being selected to contest ALAC, a discretionary judgement regarding eligibility will be made by the Selection Committee.
 - (ii) Where insufficient nominations are received, places may be extended to those who finished in the top four.
- (d) 2 places in each of 14 disciplines are offered to able-bodied competitors and 2 places in each of 8 disciplines for multi-class (In each of the boys' and girls' categories).
- **(e)** Multi-Class competitors must have a provisional or full classification.

1.5.4 Under 15 Individual Competition

- (a) The State Team Selection Committee will select and/or finalise the selection of Under 15 competitors.
- (b) The team will consist of up to 28 boys and 28 girls (Able-bodied), and up to 16 Multi Class competitors.
 - (i) A further one competitor in each of the boys and girls combined event will be selected.
- (c) In the first instance, the top two placed competitors at the current season LAVic State Track & Field Championships, in each contested discipline, will be considered for selection to ALAC.
 - (i) In the case of a draw that would result in more than LAVic's allotment being selected to contest ALAC, a discretionary judgement regarding eligibility will be made by the Selection Committee.
 - (ii) Where insufficient nominations are received, places may be extended to those who finished in the top four.
 - (iii) In the first instance, the top placed competitor from the LAVic State Combined Event Championship will be considered for selection to ALAC.

- (1) Please note that competitors selected to contest the Combined Event will not be eligible to contest an individual discipline at ALAC.
- (d) 2 places in each of 14 disciplines, plus a combined event place, are offered to able-bodied competitors and 2 places in each of 8 disciplines for multi-class (In each of the boys' and girls' categories).
- **(e)** Multi-Class competitors must have a provisional or full classification.

1.5.5 Training Sessions

- (a) Under 13 competitors will be required to attend two training sessions held on:
 - (i) 24th March Ringwood
 - (ii) 21st April Williamstown
- (b) Attendance at all training sessions is vital to the selection process for Under 13 competitors. Those who cannot commit to this, may not be selected.
- (c) Under 14 and 15 competitors who will be seeking the assistance of team coaches at ALAC will be encouraged to attend these training days.

1.6 ADMINISTRATION

- (a) All Team members will be required to purchase certain uniform items, where not already owned.
- (b) Each competitor selected in the LAVic State Team will be required to pay a levy. This levy is reviewed annually.
- (c) The balance of the cost of travel, accommodation and meals will be invoiced to the competitor's Centre.
