All metro Melbourne Centres that have not previously received authorisation from LAVic to commence their seasons must sign a copy of the Protocols and return to LAVic at office@lavic.com.au as soon possible.

Upon receipt, LAVic will grant formal authorisation to Centres to commence their season and take steps to open membership portals.

Again, Centres are not permitted to commence conducting training and competition until they have agreed to comply with the COVID-19 Protocols and formal authorisation is sought and received.

Sport & Recreation Victoria (SRV) have mandated the requirement for LAVic and all Centres to have a 'COVID Safe Plan'. SRV have yet to release the template, but it is expected within the week.

LAVic will complete a document for adaptation by Centres to meet their Centre specific requirements.

During the season, Centres will be required to maintain an up to date COVID-Safe Plan, and produce a copy at the request of an authorised officer.
