Get Active Kids Voucher Program

Round 5 applications for the *Get Active Kids Voucher Program* are open and will be accepted until 30th November 2022.

Families will need to consider their eligibility for the Program and can apply for a voucher via the following link <https://service.vic.gov.au/services/apply-for-get-active-kids-voucher/home>

Vouchers can be used to receive up to \$200 off the cost of membership registration fee (as well as any included competition uniform items).

Reimbursements remain available in Round 5 if an eligible applicant has already paid for their membership registration fee (and competition uniform items in the same transaction), back to 1st January 2022.

An eligible applicant can **ONLY** apply for either one voucher **OR** reimbursement per eligible child in Round 5.

LAVic has registered as an 'activity provider' for parents/guardians to select when redeeming their vouchers.

The Department of Jobs, Precincts & Region reached out to LAVic to suggest it administer the voucher redemption process. Accordingly, families from all Centres should select Little Athletics Victoria as the activity provider.
