In addition to the current protocols LAVic Regional Victoria COVID-19 Protocols (08.10.21), the following restrictions are to apply from Friday October 15th:

Vaccination requirements for community sport

The Victorian Government has announced vaccination requirements for employees and volunteers working in community sport. This includes contractors and students on placement.

The mandate will apply to all LAVic employees and volunteers (this includes those employed, contracted to, and volunteering at Centres & Clubs affiliated with LAVic, as well as those employed and volunteering at Region and Association level).

By **15 October 2021**, these individuals must be able to provide evidence that they have:

- received their first dose of a COVID-19 vaccination, or
- have evidence of a booking to receive their first dose by 22 October 2021, or
- have a medical exemption, evidenced by an authorised medical practitioner.
